- (iv) Conditions (i) & (iii) will exceptionally not apply to sellers whose name appear on our survey list (2014 and 2015) and actually trading on Saturdays or any other day in the Village Council Area of Riviere Des Anguilles.
- (v) At time of application, applicants should submit a copy of their National Identity Card, proof of residential address (recent CEB, CWA, MT bills) and a recent Unemployment Card delivered by the Ministry of Labour, Industrial Relations and Employment, Business Registration Card.
- (vi) Priority will be given to the sellers whose name appear in the survey list of the Council.
- (vii) A drawing of lots exercise will be done by an Independent Committee in the presence of an Usher of a Court of Law on a date and place to be approved by the Council.
- (viii) Each successful applicant will be allotted only one stall in the Market/Fair and will be allowed to operate on only one fair day except otherwise decided by the Council.

 - Registered Vulnerable families and registered SME's.
- (x) Successful applicants will be required to produce the original of all the above-mentioned documents before the signature of contract.

- (xii) The successful applicant shall pay the prescribed yearly fee and the appropriate Trade Fee to the Council.
