The District Council of Savanne is inviting Expression of Interest (EOI/01/20-21 –Legal Services) from Barristers-at-Law having at least 3 years standing at Bar and Attorneys- at law having at least 3 years practice to provide their services to this Council on an as and when required. They should both have previously provided legal services to Local Authorities

The selected Attorneys-at-law and Barristers-at-law will be required to provide advice to the Council in the transaction of its businesses and in accordance with the scope of work. The District Council proposes to retain the services of Attorneys-at-law and Barristers-at-law for an initial period ending 30 June 2021 as from date of award of contract and which may be extended for a further period subject to satisfactory performance.

Eligibility Criteria

- (i) Barristers-at-Law having at least 3 years standing at Bar and Attorneys- at law having at least 3 years practice. They should both have previously provided legal services to Local Authorities
- (ii) The selected Attorney-at-law and Barrister-at-law should be available to discuss urgent issues even outside normal working hours.

Scope of Work

- (i) In respect of the Barrister-at-law to provide legal advice to the Council and vetting of documents.
- (ii) In respect of the Attorney-at-law to instruct the Barrister for cases before the courts and other instances.
- (iii) To appear on behalf of the Council in Disciplinary Committees and defend the interest of the Council before the Public Bodies Appeal Tribunal, the Environment and Land Appeal Tribunal and other Bodies/Authorities, as and when required.
- (iv) To represent the Council in District, Intermediate, Industrial and Supreme Courts.
- (v) To advise on enforcement of legislations having to do with the Management of Council's affairs.

Other Terms and Conditions

- (i) The services would be retained as and when required by the Council.
- (ii) The Council reserves the right to annul the invitation without assigning any reason thereof.
- (iii) The Council reserves the right to call for any clarification/information.
- (iv) The Council reserves the right to discontinue the services of the Attorney-at-law and Barrister-at-law retained by giving one month notice or forthwith in case of non-satisfactory performance.
- (v) The Attorney-at-law and Barrister-at-law can discontinue their services by giving one-month advance notice.

- (vi) Payment will be effected after submission of invoice with copy of judgment.
- (vii) **An annual retainer fee will be paid only to the Barrister-at-Law** for tendering legal advice and vetting of documents as and when required during the specific period of time.
