- 1) The vehicles may be viewed at the workshop of the District Council on appointment with the Chief Health Inspector or Ag. Head Public Infrastructure Department during office hours on working days only from 13.00 hours to 14.00 hours.
- 2) A deposit of 10% of the tendered amount by way of banker’s cheque drawn in favour of ‘The District Council of Savanne’ shall be submitted with the tender for each vehicle for which bid is being submitted (**separate deposit for each vehicle**). Deposit (s) will be returned to unsuccessful bidders. Personal Cheques will **not** be accepted.
- 3) Successful bidders shall effect payment and take delivery of the vehicles within ten (10) days as from the date of the letter of award failing which the offer will lapse and the deposit forfeited.

Bids are invited for the sale of vehicles on an ‘as is where is’ basis.

Instructions to Tenderer

- 1) The vehicles are to be sold on an ‘as is where is’ basis.
- 2) The bid should be accompanied by a Security Deposit in the form of an office cheque drawn in favour of the District Council of Savanne from a local commercial bank.
- 3) The security deposit shall be forfeited where the bidder withdraws his bid or fails to honour his offer.
- 4) Bids shall be made in the prescribed Bid Form and the bidder shall complete the bid form, sign and insert the date in the space provided in the document.
- 5) The tender document must be enclosed in a sealed envelope bearing wording “Offer for Sale of Vehicles” but should not bear any mark in whatever form, to indicate the identity of the bidder.
- 6) Bids addressed to the Chief Executive should be deposited in the Tender Box during normal working hours at the Administration Department, District Council of Savanne by **Monday 21 December 2020 at 11.00 hrs (local time) at latest**. Bids received after the closing date and time will not be accepted.
- 7) The District Council does not bind itself to accept any bid, even the highest without giving any reason thereof.
- 8) The successful bidder shall effect transfer of ownership into his name within one week after the signature of the deed of sale.
