Expression of interest received after the prescribed date and time will not be considered.

The Council reserves the right to cancel this exercise and also not to accept any expression of interest nor will it assign any reason for rejection of same.

GENERAL CONDITIONS

 The District Council is inviting expression of interest (EOI) for panels or boards to be affixed at sites mentioned (ANNEX A). All panels and boards as well as the supporting structures should resist cyclonic conditions. Precautionary measures to remove the boards before and refixing same after cyclonic weather should be at the expense of the bidder.

N.B Full technical details of all elements and supporting structures has to be provided with the EOI. A plan for each site whereby all publicity panels would be placed should also be provided.

- 2. The design of the publicity panels as well as the technical details should be submitted.
- 3. The prospective bidders should make their own provision for power supply including application procedures and meet all costs thereof. The installations should be appropriate for normal power supply of 220 230V (50Hv) for outdoor purposes. Equipment should comply with international standards and all safety norms shall be complied with.
- 4. Catalogues, brochures, pamphlets where applicable etc have to be submitted along with the EOI.
- Prospective bidders should be duly registered with the Corporate Business Registration Department (CBRD) and possess the relevant trade licence Evidence to be submitted along with the offers.
- 6. The contractor shall take comprehensive insurance covers for the works to be carried out and for the structure to be provided at each site.

- 7. Third party liability shall be the responsibility of the bidder. The value of any one occurrence or series shall be not less than Rs 1,000,000.
- 8. No casting work or any work that requires approval of the Council shall be carried out on week-ends that is Saturday, Sundays and public holidays.
- 9. Bidders should submit their financial bids as per annexed form Annex A.
- 10. A security deposit of Rs 15,000 from a Local Commercial Bank (office cheque) in the name of The District Council of Savanne
- 11. Publicities affixed thereon shall be in compliance with all laws and regulations in force at the time of bid or which may come in force thereafter. The Publicity to be displayed should not be of political, religious, immoral nature and would not obstruct the visibility of bus drivers.
- 12. The Bidder shall be solvent and up to date with Mauritius Revenue Authority Returns and the relevant certificates/ documents shall be submitted accordingly.
- 13. The Construction, Fixing and Maintenance of Publicity Panels shall be at the cost of the successful Bidder.
- 14. The period of lease is for a period of 3 years. Contract may be renewed for 2 additional periods of 12 months upon satisfactory performance of the preceding period to the Council.
