**GENERAL INFORMATION**

By virtue of Section 57(1)(a) of the Local Government Act 2011 as subsequently amended, this Council invites Expressions of Interest **solely** from residents within **the administrative area of The District Council of Savanne** for the occupation of vacant stalls at the **New Chemin Grenier market/fair**, for an initial period of 3 years, on such terms and conditions as may be determined by the Council:

**1) Instructions to Applicant**

- i) All parts of the application form should be filled by the Applicant except the part meant for office use.
- ii) The form should be duly signed by the Applicant.
- iii) At time of application, the Applicant should submit a copy of :
  - a) His/Her National Identity Card,
  - b) His/Her Birth Certificate/Marriage Certificate as applicable,
  - c) A Proof of residential address (CEB or CWA or Mauritius Telecom bills-Not more than 3 months
  - d) Rent Book(where applicable)
  - e) Unemployment Card

**2) Eligibility Criteria of The Applicant**

- i) Be a resident of **the District Council of Savanne Area**.
- ii) Has reached his/her 18<sup>th</sup> birthday at time of application.
- iii) Applicant **should not be an occupier of any stall** in any market/fair, shop or other place inside a market or fair and should not hold any business within the jurisdiction of the District Council of Savanne or any other Local Authority.
- iv) Applicant should be unemployed .

**3) General Conditions**

1. Only Applicants satisfying the **eligibility criteria** will be called for a drawing of lots exercise that will be done in the presence of an Usher of a Court of Law on a date and place to be approved by the Council.
2. Only one stall shall be allocated to an applicant.
3. Successful Applicants will be required to produce the original of all the above mentioned documents at **1(iii)** prior to participating in the drawing of lots exercise.
4. Successful applicants will have to swear an Affidavit stating the veracity of the application.
5. Successful Applicants shall personally occupy the stall allocated to her/him.
6. The successful Applicant shall pay the prescribed yearly fee for occupation of the stall allocated to him/her as per **Table (1)**:
